The Jackson South project area consists of Frontier's existing footprint in Jackson County, specifically covering Cashiers, Glenville, and other nearby communities. This project will provide 1,118 grant-eligible locations in the Jackson South project area with symmetrical, 2-Gigabit fiber. ### Checklist Details

1) Statement of Qualifications (Please provide a detailed description of qualifications and experience with the deployment of broadband):

Frontier and its affiliates have provided telephone and broadband service in 25 states across the Country for many years. Frontier is well-positioned to efficiently undertake and execute this Project. Frontier is not "new" to fiber broadband services or the County. As an incumbent provider of telecommunications service in the County, Frontier has an established network and local personnel in the community. The Project would leverage Frontier's existing infrastructure and assets, including existing land, buildings, power systems, poles, conduit, and fiber. The Project also leverages Frontier's service-related capabilities including its established sales, customer support, and service functions.

In April 2021, Frontier Communications of the Carolinas LLC ("Company"), with its parent company and affiliate companies (collectively, "Frontier"), adopted a new vision for the future - Building Gigabit America. The Company, with its new board and leadership (biographies attached to this application as a separate file), is positioned to leverage its experience as a broadband provider with its new vision and strong liquidity to enhance and expand broadband availability both through its private investment and through public-private partnerships. Our new organization is focused on bringing highly resilient, fully fiber facilities initially delivering symmetrical gigabit service, with plans to increase symmetrical speed offerings in 2022, over a highly scalable network. Importantly, Frontier is committed to broadband adoption and has low-income service offerings to assure all residents can realize the benefits of the service to meet the growth of at-home learning. As part of its commitment to Build Gigabit America, during just 4Q 2021, Frontier completed construction projects to pass 192,000 additional locations nationwide with its fiber network, for a total of 638,000 new locations during the 2021 calendar year. Frontier is already on the path for even more accelerated deployment in 2022.

Frontier's 85+ years of knowledge and expertise in building, operating, and maintaining telecommunications networks with the best of today's innovations to

deliver premier internet connectivity – gigabit Fiber-to-the-Premises (FTTP)/Fiber-to-the-Home (FTTH) services – positions the Company to provide symmetrical gigabit broadband service in the Project Area.

2) Assessment of the current level of broadband access in the proposed deployment area – supporting data may be uploaded if applicable:

The Jackson South project area consists of Frontier's existing footprint in Jackson County, specifically covering Cashiers, Glenville, and other nearby communities.

According to Appendix E of the GREAT Grant Guidance document, there are 13,016 grant-eligible locations in Jackson County that currently do not have access to 25Mbps/3Mbps broadband speeds.

Within Frontier's footprint, we have identified 1,118 that can be feasibly served with support from grants. 1,060 of these unserved locations were identified using a combination of FCC Form 477 data and responses from the NC Broadband Community Survey. To identify these locations, we first located census blocks in Form 477 data that reported speeds of 25Mbps/3Mbps or less. We then augmented this list to include respondents that reported 25Mbps/3Mbps or less on the NC Broadband Community Survey, regardless of whether their census block reported higher speeds to Form 477. We assumed that each respondent represented one location.

The remaining 58 locations we identified came from census blocks in which Frontier is the highest-speed provider, and the only provider reporting speeds higher than 25Mbps/3Mbps for some locations in those census blocks. However, these 58 locations have actual speed capabilities of less than 25Mbps/3Mbps per Frontier's location serviceability data, confirming they are in fact unserved.

Other than these specific exceptions, we excluded locations that reported speeds higher than 25Mbps/3Mbps on FCC Form 477 and the NC Broadband Community Survey. Per GREAT guidelines, we also excluded locations that fell into areas previously awarded GREAT Grants, GREAT Ineligible Tracts, and Protected Areas ineligible due to receiving rewards from other broadband funds such as RDOF.

3) Description of Proposed Services, Advertised Speeds, and Pricing Structure for proposed broadband recipients in the eligible project area:

The FTTP services Frontier Communications of the Carolinas LLC expects to offer are its national Gigabit broadband service tiers and prices for symmetric speeds of up to 2Gbps. As an example of Frontier's residential pricing, the lowest tier residential retail offering is a symmetrical 500Mbps service for \$59.99 per month (after a \$5 discount for paperless billing and auto-pay). A \$10 introductory monthly discount may also apply, which could reduce monthly pricing to as low as \$49.99 for the first year. Frontier does not currently require a contract for this pricing and no early termination fee applies.

A complete chart of service tiers and pricing is provided in an attachment to this application. Frontier's current national fiber price plans do not have any connection charges, equipment rental fees or data caps. While prices may change somewhat over time, Frontier expects that its current pricing is representative of what is likely to be available once the Project is complete. Furthermore, Frontier's current pricing is consistently some of the most competitive nationwide. That will remain true going forward.

Because the Company participates in the FCC's Affordable Connectivity Program (ACP), a free 100Mbps symmetrical service would be available to qualified low-income customers in the proposed Project Area (discounts on higher speed tiers would also be available). Frontier also participates in the Federal Lifeline program which offers a monthly discount of \$9.95 per household.

4) Description of Adoption Plan:

Frontier utilizes a variety of communications channels to alert the community about the Project and that new fiber broadband services are (or will be) available in the Project Area and to otherwise advertise the Project and its services. In general, Frontier attempts to use the channels that it has determined will be most effective in a Project Area. Frontier expects to use some or all of the following outreach tactics, which it has successfully utilized for other, similar projects to raise community awareness and to drive adoption of deployed broadband services:

- Collaboration with community-based organizations, local consortium and local officials
- Cooperation with county social service agencies, the public school systems and local college campuses, food banks, senior centers, libraries, etc. to promote the availability of low-income offers
- Direct mailers
- Local newsprint
- Postcard mailings to current Lifeline telephone customers and other publication/promotion of its low-income offers to under/unserved populations
- Outdoor signage
- Media ads
- Ribbon Cutting or other local events

Frontier is committed to partnering with community resources to help ensure community awareness and adoption of deployed high-speed services.

Frontier also utilizes the above methods to increase awareness of the FCC's Affordable Connectivity Program and the low-cost service options that Frontier offers through this program.
